

In accordance with Article II, Section 3(c) of the Constitution and By-Laws, we the undersigned take great pleasure in nominating, and/or seconding the nomination of the following members of the Association for DISTINGUISHED MEMBERSHIP. CHSCLK HUBERT CRAVEN. National Association President 1960 and 1961 was previously nominated for DISTINGUISHED MEMBERSHIP but his nomination was tabled at the June 1966 meeting of the National Council. The only reason we moved that his nomination be tabled was to permit us to submit his name in the block of six names listed above, all of which we believe have equally distinguished themselves in the Association far above that which was required or expected of them.

Their length of membership in the Association range from 14 years for Mr. Terry to 28 years for Mr. Van Winkle. Each of these gentlemen was elected President of the Association for a one year term, and due to the outstanding job each performed during that year, was REELECTED by the Association membership for another year. That reelection to the highest position in the Association proves the confidence and satisfaction of the members in these men for services already performed.

In addition to serving as President for more than one year, each of them have served in other positions of responsibility which include: Vice-President- Messrs Bradley, Terry, Hayman and Craven. Chairman of the National Council- Messrs Van Winkle, Daisey, Terry, Craven and Hayman. Each of these also served as Chairman of various Committees and filled other positions in the National Council. It is impossible to state all of the contributions and accomplishments each devoted to the Association, yet we believe their records will suffice to elect them to the position of DISTINGUISHED MEMBERSHIP.

Due to the present By-Laws, CHSCLK LEE R. GREEN, present (and past) President is not presently eligible for DISTINGUISHED MEMBER status, however, at this time we wish to place his name for nomination to such status to become effective on the first day of the first month after he relinquishes his present position in the Association. His record speaks for itself inasmuch as he has been reelected TWICE as National President. His devotion and contributions to the Association are well known by the entire membership and therefore needs no elaboration. We take great pleasure in being the first to nominate him for DISTINGUISHED MEMBERSHIP to become effective as soon as he is eligible.
